1. *Nepalgunj Sub-Metropolitan City, Nepalgunj, Banke* has allocated funds towards the cost of **Supply, Delivery, Installation, Testing and Commissioning of CCTV System in Nepalgunj Submetropolitan City**, and intends to apply part of the funds to cover eligible payments under the Contract for, **Contract ID: NSMC/NCB/ITW01/2082/83**. Bidding is open to all eligible as per Section V of bidding document.
2. *Nepalgunj Sub-Metropolitan City* invites electronic bids from eligible bidders for the construction of **Supply, Delivery, Installation, Testing and Commissioning of CCTV System in Nepalgunj Submetropolitan City**, under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs. 4,11,000,00.00(Four Crore eleven lakhs rupees only)]**
 - Minimum Work experience of similar size and nature: **[as specified in Terms and Condition of Bid Document]**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit
 4. simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the cost of bidding document **ie Nrs. 5000** in the Project's Rajaswa (revenue) account as specified below.

7. Pre-bid meeting shall be held on 10 days before the bid opening date at *Nepalgunj Sub-Metropolitan City* 1:00 PM.
8. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon** of 22 days from the bid issued date . Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00PM on the bid opening date**, at the office of *Nepalgunj Sub Metropolitan City*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 6,85,000.00** which shall be valid for 30 days beyond the validity period of the bid.
